ARTICLES OF INCORPORATION OF

KINGS RIVER ESTATES NO. 2 MAR 0 4 2002 PROPERTY OWNER'S ASSOCIATION, INCorporations Section

I, the undersigned natural person over the age of eighteen (18), acting as an incorporator, adopt the following Articles of Incorporation of KINGS RIVER ESTATES NO. 2 PROPERTY OWNER'S ASSOCIATION, INC. (referred to as the "Corporation") under the Texas Non-Profit Corporation Act (referred to as the "Act"):

ARTICLE 1 NAME

The name of the Corporation is KINGS RIVER ESTATES NO. 2 PROPERTY OWNER'S ASSOCIATION, INC.

ARTICLE 2 NONPROFIT CORPORATION

The Corporation is a nonprofit corporation.

ARTICLE 3 **DURATION**

The duration of the Corporation is perpetual.

ARTICLE 4 PURPOSES

The Corporation is formed for the following purposes:

- 1. To monitor the development of the real property known as Kings River Estates, Section Three, a subdivision located in Harris County, Texas (the "Property") which is subject to the Declaration of Covenants, Conditions and Restrictions (the "Declaration") to be recorded in the Real Property Records of Harris County, Texas, and incorporated herein as though fully recited verbatim;
- 2. To preserve the values and amenities of the Property for the better development, improvement, sale, use and enjoyment of it as set forth in the Declaration;
- 3. To exercise the power of maintaining, administering and enforcing the provisions of the Declaration and levying, collecting and disbursing the assessments and charges therein created;
- 4. To exercise any other power, right or privilege permitted or required of a corporation organized under the Act as now in force or hereafter amended.

ARTICLE 5 INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Corporation is 19111 Walden Forest Drive, Humble, Texas 77346. The name of the initial registered agent at this office is Ronald R. Holley.

ARTICLE 6 RESTRICTIONS AND REQUIREMENTS

The Corporation shall not pay dividends or other corporate income to its members, directors or officers or otherwise accrue distributable profits or permit the realization of private gain. The Corporation shall have no power to take any action prohibited by the Act.

ARTICLE 7 MEMBERSHIP

Every Owner, as defined in the Declaration ("Owner") shall be a member of the Corporation.

ARTICLE 8 VOTING RIGHTS

The Corporation shall initially have two (2) classes of voting membership and each Owner shall have votes as follows:

Class A:

The Class A members shall be all Owners, with the exception of Declarant, (as defined in the Declaration of Covenants, Conditions and Restrictions for Kings River Estates, Section Three) and shall be entitled to one vote for each Lot owned in the Property. In the case of fractional votes, the vote shall be rounded off to the nearest whole number. When more than one person holds an interest in any Lot in the Property, the vote for such land shall be exercised as they among themselves determine but in no event shall more than one vote be cast with respect to any Lot.

Class B:

The Class B member shall be the Declarant and such Owner shall be entitled to ten (10) votes for each Lot owned in the Property. In the case of fractional votes, the vote shall be rounded off to the nearest whole number. The Class B membership shall cease and be converted to Class A membership on the earlier of (i) December 31, 2031, or (ii) such earlier date as Declarant, in its discretion, so determines and records an instrument to such effect in the Real Property Records of Harris County, Texas.

ARTICLE 9 BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors. The qualifications, manner of selection, duties, terms, and other matters relating to the Board of Directors shall be provided in the bylaws. The initial Board of Directors shall consist of three persons. The number of directors may be increased by adoption or amendment of bylaws. The initial Board of Directors shall consist of the following persons at the following addresses:

ARTICLE 10 LIMITATION ON LIABILITY OF DIRECTORS

A director is not liable to the Corporation or to the members for monetary damages for an act or omission in the director's capacity as director except to the extent otherwise provided by statute.

ARTICLE 11 INDEMNIFICATION

Pursuant to the section of the Act governing indemnification, the Corporationmay indemnify a person who was, is, or is threatened to be made a named defendant or respondent in litigation or other proceedings because the person is or was a director or other person related to the Corporation. The Bylaws give the Board of Directors shall have the power to define the requirements and limitations for the Corporation to indemnify directors, officers, or others related to the Corporation.
